WHAT IS THE CRS PUBLIC WORKS PROFESSIONAL DEVELOPMENT PROGRAM?

The CRS is a 'legal' professional public works accreditation. The CRS program is designed to elevate professional standards, enhance individual performance, and designate association professionals who demonstrate the knowledge vital to public works management.

In April of 1996, AORS was granted—by Provincial Legislation (*Association of Ontario Road Superintendents Act; Bill PR53*)—the exclusive right to use the designation "Certified Road Supervisor" and "CRS". Therefore, the CRS accreditation program is recognized under Provincial Statute Law.

WHO IS ELIGIBLE FOR THE CRS?

The CRS program is widely recognized and highly successful. Over 1200 designations have been awarded to public works personnel throughout Ontario. A certain combination of education, experience, and continuing professional development is required to earn the credential.

If you are an employee within the private/Municipal sector hired to supervise construction, rehabilitation or maintenance of core civil public works infrastructure you are eligible to apply for AORS Certified Road Supervisor (CRS) public works professional development accreditation.
